The application and examination dates for these certification programmes are as follows:

a. FIDIC Certified Adjudicators:

Deadline to apply: 25 February 2022

Phase 1 exam: 9 March 2022

Phase 2 assessment: 22 and 23 March 2022

b. FIDIC Certified Consulting Practitioner):

Deadline to apply: 16 February 2022

Exam: 24 February 2022

c. FIDIC Certified Contract Manager:

Deadline to apply: 18 March 2022

Exam: 30 March 2022
